- 2. ALL RESERVATIONS ARE SUBJECT TO PROCUREMENT OF PERMISSIONS / LICENCE AS PER GOVERNMENT RULES REQUIRED FOR THE FUNCTION AND PRODUCTION THEREOF BEFORE TO THE CLUB'S MANAGER BEFORE 48 HOURS OF COMMENCEMENT OF THE FUNCTION.
- 3. ALL RESERVATIONS ARE SUBJECT TO CANCELLATION WITHOUT ANY PRIOR NOTICE FOR THE REASONS BEYOND THE CONTROL OF THE CLUB.
